

### **TEMPORARY STATE PISTOL PERMIT APPLICATION**

The guidelines for obtaining both a local and state pistol permit are contained in Connecticut General Statutes §29-28, §29-28a, and §29-29. Applicants must be at least 21 years old and be a legal resident of the Town of Southbury. Persons convicted of a felony or any one of 11 misdemeanor offenses detailed in the statute are ineligible to receive a permit.

Applicants must bring a completed and notarized application with all the documents listed above to the Southbury Police Department Records Division, Monday – Friday, 7:30 AM - 1:00 PM, or 2:00 PM - 3:30 PM. Where requested, please bring copies as original documents will not be accepted and copies will not be made.

After you submit your application and payment to the Records Department, you will receive a "CT Criminal History Request System Fingerprint Service Code" card. **DO NOT** share the provided service code with anyone. Applications are subject to rejection if the applicant is ineligible for any reason as set forth in the Connecticut General Statutes or if any information is developed during the background investigation that shows the applicant should not be allowed to carry a firearm.

You will be notified via phone when your temporary permit is available for pick-up. Processing times vary and may take up to 4 months to complete. For pistol permit related questions, please call the Southbury Police Department Records Division, Monday – Friday, 7:30 AM – 3:30 PM at 203-264-5912.

#### **Noncriminal Justice Applicant's Privacy Rights**

#### Requesting Entity: Southbury Police Department

As an applicant who is the subject of a national fingerprint-based criminal history record check for a noncriminal justice purpose (such as an application for employment or a license, an immigration or naturalization matter, security clearance, or adoption), you have certain rights which are discussed below. **All notices must be provided to you in writing.** <sup>1</sup> These obligations are pursuant to the Privacy Act of 1974, Title 5, United States Code (U.S.C.) Section 552a, and Title 28 Code of Federal Regulations (CFR), 50.12, among other authorities.

- You must be provided an adequate written FBI Privacy Act Statement (dated 2013 or later), by the agency that will receive your criminal history results, when you submit your fingerprints and associated personal information. This Privacy Act Statement must explain the authority for collecting your fingerprints and associated information and whether your fingerprints and associated information will be searched, shared, or retained. <sup>2</sup>
- You must be advised in writing of the procedures for obtaining a change, correction, or update of your FBI criminal history record as set forth at 28 CFR 16.34.
- You must be provided the opportunity to complete or challenge the accuracy of the information in your FBI criminal history record (if you have such a record).
- If you have a criminal history record, you should be afforded a reasonable amount of time to correct or complete the record (or decline to do so) before the officials deny you the employment, license, or other benefit based on information in the FBI criminal history record.
- If agency policy permits, the officials may provide you with a copy of your FBI criminal history record for review and possible challenge. If agency policy does not permit it to provide you a copy of the record, you may obtain a copy of the record by submitting fingerprints and a fee to the FBI. - If you decide to challenge the accuracy or completeness of your FBI criminal history record, you should send your challenge to the agency that contributed the questioned information to the FBI. The FBI will then forward your challenge to the agency that contributed the questioned information and request the agency to verify or correct the challenged entry. - You have the right to expect that officials receiving the results of the criminal history record check will use it only for authorized purposes and will not retain or disseminate it in violation of federal statute, regulation or executive order, or rule, procedure or standard established by the National Crime Prevention and Privacy Compact Council.<sup>3</sup>
