### **Liquor Service in Connection with Outside Dining:**

Please refer to Section 3 of Governor Lamont's Executive Order No. 7MM for guidance on "Liquor Service in Connection with Outdoor Dining".

For the duration of the Executive Order banning inside dining, the CT Department of Consumer Protection, Liquor Control Division has provided guidance on expanding liquor sales to outdoor dining venues. The Town will work in concert with this guidance, and ask restaurants to submit the state and Town applications simultaneously for faster review and approval. Look for the form "Patio/Extension of Use, and/or Additional Consumer Bar" Application. #### **Building Department Approval is necessary for Tents in conjunction with Temporary Outdoor Seating:**

- Tents *with* sides are *not* permitted in conjunction with temporary outside seating approved in response to the Governor's executive order
- Tent structures over 700 square feet in area without sides require a building permit
- Multiple tent structures with a congregate area exceeding 700 square feet require a building permit
- Building permits may also be required for outside lighting, heating and other temporary improvements.
